## **EXTENDED TRADING AT LAST PHASE FOR EQUITIES TRADED CONTINUOUSLY ON 20 MARCH 2020**

### **Executive Summary**

On Friday 20 March 2020, the Trading At Last phase for securities traded continuously on the Equities segment will be extended by 10 minutes (5 minutes for Euronext Dublin) and will last 15 minutes.

Euronext informs market participants that on Friday 20 March 2020, the Trading At Last phase for securities traded continuously on the Equities segment will be extended by 10 minutes (5 minutes for Euronext Dublin) and will last 15 minutes in total.

### **DETAILS**

- Due to exceptional market conditions foreseen on Friday 20 March 2020, the Trading At Last phase for securities traded continuously on the Equities segment will last 15 minutes.
- The extended Trading At Last phase will apply to Equities traded continuously on the Euronext Amsterdam, Brussels, Dublin, Lisbon and Paris markets.
- The Trading At Last phase for these instruments will end at 17:50 CET instead of 17:40 CET for all Euronext markets except Dublin. For the Euronext Dublin market, the Trading At Last phase will end at 17:45 CET instead of 17:40 CET.
- All other instruments will follow their usual timetable.
- For the constituents of Euronext's major indices, Euronext will proceed, during the Trading At Last phase, to the reopening of the instruments which may have been halted during the closing auction.
